## AMENDMENT OF COVENANTS PLAT OF WOODLAKE

## PLEASE TAKE NOTICE:

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for the Plat of Woodlake, as recorded under Auditor's No. 2305152, records of Pierce County, Washington, provides for amendment of the Declaration by an instrument signed by not less than seventy-five percent of the Lot Owners within the Plat of Woodlake; and

WHEREAS, more than seventy-five percent of the Lot Owners have signed an instrument providing for the amendment of the Declaration as below stated; and

WHEREAS, the Board of Trustees of the Woodlake Homeowners Association, a Washington nonprofit corporation, desire to make the amendment a matter of public record;

NOW, THEREFORE, the Board of Trustees certify and declare that Article XIII of the Declaration is amended by the addition of a new Section 5 which reads as follows:

<u>Section 5. Plebiscites Conducted by Mail.</u> As an alternative to a meeting of Lot Owners, the approval or consent of Lot Owners for any matter may be obtained by a plebiscite conducted by mail in such manner as the Board of Trustees of Woodlake Homeowners Association shall determine; provided, however, that each referral shall provide Lot Owners and Association Members with postage prepaid return envelopes for the return of ballots for or against the matter referred. All matters submitted to Lot Owners pursuant to this Section shall be decided by majority vote of members voting on the matter referred.
